Dear Ms. D'Andre: Following is our response to items 1 and 2 in your message requesting records or information regarding the Indiana child support program, that we received on March 8, 2017.

1. The total number of "open cases" in the Indiana child support computer system, as of March 11, 2017, is 568,674. The number of Title IV-D cases included in that total is 280,498.

2. The attached table shows the arrears amounts owing by the child support obligors in the "top 100" Title IV-D cases, listed in descending order of the amounts owing as of March 11, 2017. Our system does not contain that information for the non-IV-D open cases.


As advised in my initial response message on March 14, 2017, we are not able to provide information regarding which cases include in the arrearage amounts any interest on the arrearages that may have been included in a court judgment. The Indiana statute allowing for interest on child support arrearages applies only if a request is made to the court to include interest on the judgment. Indiana Code 31-16-12-2. DCS does not request inclusion of interest on arrearage judgments.
