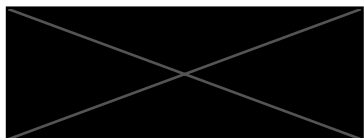

1. The number of open cases with the Child Support Program in the State.


RESPONSE: Maine currently has 46,676 open child support cases
