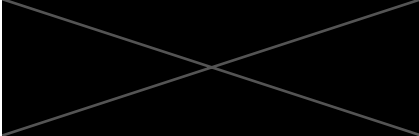

- The number of open cases with the Child Support Program in the State.
- The top 100 cases with the highest balances due in the State. For example, #1- \$1 + million, #2 - \$975k and so on.
- Clarification on the amount due. Does it represent support due or support plus interest (if in judgment)?

And specifically:

- I would like to request the balances on the top 100 cases where the child support program is providing services to the custodial party, and I am only requesting only the top 100 child support balances.
