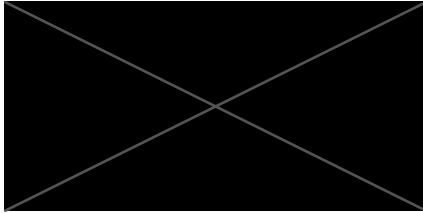

Dear Ms. D'Andre,

This letter responds to your Freedom of Information Law (FOIL) request of January 25, 2017, in which you requested:

1. "The number of open cases with the Child Support Program in the state."
2. "The top 100 cases with the highest balances due in the state."
3. "Whether or not these balances reflect the principal balance only, or do they reflect principal, interest, and fees?"

The Office of Temporary and Disability Assistance (OTDA) is hereby granting your request. Attached for your review is a copy of the responsive record to your request. Please note that certain portions of the responsive record are redacted pursuant to Public Officers Law § 87(2)(b), as disclosure would constitute an unwarranted invasion of personal privacy. Also, certain portions of the document have been redacted as they are not responsive to your request.

Regarding items 1 and 3 of your request, please know that Public Officers Law § 89(3) provides, in part, that an agency is not required to create a record in response to a request. Similarly, nothing in FOIL requires an agency to supply information in response to questions. However, OTDA is willing to make an exception in this case.

In response to item 1 of your request, there are 882,335 open cases as of 12/31/2016. In response to item 3 of your request, the document provided to you contains three columns titled: "Past Due," "Judgment," and "Interest." Fees are not included in the total amount.

Should you choose to appeal this decision, kindly send your written appeal to OTDA's Appeals Officer, Craig Crist, at 40 North Pearl Street, Albany, New York 12243 or via email to appealofficer@otda.ny.gov within 30 days in accordance with Public Officers Law section 89(4)(a).



