As of December 31, 2016, there are 183,961 open cases with the Oregon Child Support Program

Cases without an amount in the “Current Support Due” column are cases where support is no longer being billed and the case is open for collection of the past due support only or cases where full payment due for the month of march was paid prior to this report date.
