

PUBLIC RECORDS REQUEST FORM

The Tennessee Public Records Act (TPRA) grants Tennessee citizens the right to access open public records that exist at the time of the request. The TPRA does not require records custodians to compile information or create or recreate records that do not exist.

Under the TPRA, record requests must be sufficiently detailed to enable a governmental entity to identify the specific records sought. As such, your record request must provide enough detail to enable the records custodian responding to the request to identify the specific records you are seeking.

As a US citizen, I am requesting to obtain copies of public records that pertain to the Child Support Program of your State. The records I am requesting are as follows:

1. The number of open cases with the Child Support Program in the State.
2. The top 100 cases with the highest balances due in the State. For example, #1 – \$1+ million, #2 – \$975k and so on.
3. Clarification on the amount due. Does it represent support due or support plus interest (if in judgment).

This data is for research purposes. I stress that I do not want, nor am I requesting any names. I am looking to compare each state and the largest amounts of child support due in each state.
